Purpose. The 5-Year and Annual PHA Plans provide a ready source for interested parties to locate basic PHA policies, rules, and requirements concerning the PHA's operations, programs, and services, including changes to these policies, and informs HUD, families served by the PHA, and members of the public of the PHA's mission, goals and objectives for serving the needs of low- income, very low- income, and extremely low- income families

Applicability. The Form HUD-50075-SM is to be completed annually by **Small PHAs**. PHAs that meet the definition of a Standard PHA, Troubled PHA, High Performer PHA, HCV-Only PHA, or Qualified PHA do not need to submit this form.

Definitions.

- (1) **High-Performer PHA** – A PHA that owns or manages more than 550 combined public housing units and housing choice vouchers and was designated as a high performer on both the most recent Public Housing Assessment System (PHAS) and Section Eight Management Assessment Program (SEMAP) assessments.
- (2) **Small PHA** - A PHA that is not designated as PHAS or SEMAP troubled, and that owns or manages less than 250 public housing units and any number of vouchers where the total combined units exceed 550.
- (3) **Housing Choice Voucher (HCV) Only PHA** - A PHA that administers more than 550 HCVs, was not designated as troubled in its most recent SEMAP assessment and does not own or manage public housing.
- (4) **Standard PHA** - A PHA that owns or manages 250 or more public housing units and any number of vouchers where the total combined units exceed 550, and that was designated as a standard performer in the most recent PHAS or SEMAP assessments.
- (5) **Troubled PHA** - A PHA that achieves an overall PHAS or SEMAP score of less than 60 percent.
- (6) **Qualified PHA** - A PHA with 550 or fewer public housing dwelling units and/or housing choice vouchers combined and is not PHAS or SEMAP troubled.

BHP Goals and Objectives

The goals and objectives outlined below address BHP's approach to addressing the critical issues outlined above. These goals and strategies are not intended to be a full catalog of every BHP effort, do not reflect all continuing organizational initiatives, and are not presented in order of chronology or priority. Instead, they represent the organization's key priorities over the next five years.

#1 Strengthen BHP neighborhoods.

BHP aims to facilitate a sense of pride, safety, and community for its residents. To do so, BHP will focus on improving the interior and exterior condition of its properties and increasing positive resident engagement through resident-selected activities, education, and volunteer opportunities.

- A. Improve condition and aesthetics of BHP properties.
 - Solidify capital improvement plan for BHP properties with prioritized short-term and long-term projects for each property and identification of potential revenue sources.
 - Secure funding to enhance property amenities including additional play structures, community spaces, and laundry facilities.
 - Develop organizational plan to address chronic issues of smoking, trash, and resident conflict.

- B. Increase resident engagement to develop sense of safety, belonging, and community.
 - Evaluate potential programming opportunities using resident feedback.
 - Develop staffing structure for increased family site presence and engagement.
 - Offer programming to include:
 - Education/activity classes for residents (skills: budgeting, CPR, parenting; issues: public health, homelessness; and wellness activities).
 - Mediation services for resident conflict.
 - Onsite and collaborative programs for children and youth.
 - Volunteer opportunities.
 - Increase participation from every property on the Resident Advisory and Communication Committee.

#2 Increase housing units in Brattleboro.

Brattleboro is in the midst of an escalating housing crisis with constricted conditions throughout the housing continuum, and a particular shortage of affordable housing for lower-income households. BHP has the opportunity to contribute to the development of new housing units in the community by pursuing re-development of three properties: Melrose Terrace,

Moore Court, and Hayes Court. In-town, developable parcels are increasingly rare and both of these properties offer opportunity to create new housing units. The concurrent development of the properties merits exploration. While re-development of these properties is a priority, BHP will also pursue partnerships that create new housing with voucher availability and that create housing opportunities with services for aging community residents and/or other specific populations with unmet housing needs.

- A. Explore replacement of housing units.
 - Complete Melrose Terrace Flood Mitigation project and evaluate final determination of change to flood map lines.
 - Conduct feasibility study focused on Melrose Terrace, Moore Court, and Hayes Court with the consideration of using Melrose Terrace as transitional units for other re-development projects, expanding Moore Court with mixed-income new and rehabbed units, and creating permanent housing at Melrose Terrace in the future.
 - Pursue selected housing development project as determined by feasibility study.
- B. Consider other housing development partnerships to create additional Housing Choice voucher opportunities in the community.
- C. Continue advocacy and involvement in expanding options for low-income housing with a focus on: housing with supportive services for aging in place; youth and people aging out of foster care; permanent supportive housing; and recovery housing.

#3 Foster resident, organizational, and community resilience.

Windham County's demographics trends reflect an aging population. Extreme weather events and global crisis are more frequent. BHP staff—the backbone of the organization—must grapple with these challenges, while also supporting residents who have experienced trauma, discrimination, and the impacts of generational poverty. Over the next five years, BHP will focus on efforts that foster resident, neighborhood, and organizational resilience.

- A. Support the safety and health of community residents.
 - Expand the Support and Services at Home (SASH) program's services, geography, and eligibility.
 - Pursue opportunities to develop housing with increased services for residents who can no longer live independently.
- B. Pursue energy efficiency upgrades for all BHP properties.
- C. Strengthen emergency preparedness efforts.
 - Develop resident information infrastructure.
 - Install Wi-Fi in all properties.
 - Connect residents with needed electronic communication devices.
 - Create and record resident disaster plans to include "buddy system", plans for pets, and contact list in database.

- C. Provide staff training to deepen understanding of residents and prevent professional burnout.
 - Provide staff training related to diversity, equity, and inclusion.
 - Provide staff training related to generational poverty and trauma-informed practices.

#4 Align programs and operations with Moving to Work opportunities.

BHP's shift to a Moving to Work organization creates opportunities to simplify complex processes, approach situations and challenges with more flexibility, and support residents' self-determined goals. Over the next five years, BHP will explore the opportunities afforded by the Moving to Work shift with a focus on better addressing the needs and housing goals of BHP residents.

- A. Analyze and re-organize staffing structure to support MTW and address the following:
 - Establish staffing for family site engagement and volunteer coordination.
 - Increase property management/occupancy administrative capacity.
 - Re-envision all BHP staff roles.
 - Decrease direct reporting to Executive Director by establishing Operations (Occupancy including Section 8, Finance, Maintenance) and Wellness & Services (SASH, Resident Services & Activities) departments with director-level staff members.
- B. Prioritize initiatives that reinforce resident self-determination in their housing future.
 - Provide resident education to include financial literacy and homebuyer education.
 - Pursue education and incentive programs that connect residents to alternative homeownership strategies like homeownership vouchers and multi-family investments.
- C. Simplify processes to reduce administrative and financial burdens.
 - Develop plan for income-earning young adults to avoid disincentivizing situations.
 - Move annual certifications to three years.
 - Increase self-certified assets cap.
 - Streamline property-specific applications.
 - Conduct comprehensive survey of residents and community partners to determine further changes.

#5 Create organizational and community leadership opportunities

BHP's assets include its staff members and Commissioners. Over the next five years, BHP will strengthen the internal connections between Board and staff, and also create opportunities for the organization's leaders to have a stronger external, community focus in their roles.

16. With respect to public housing the PHA will comply with Davis-Bacon or HUD determined wage rate requirements under Section 12 of the United States Housing Act of 1937 and the Contract Work Hours and Safety Standards Act.
17. The PHA will keep records in accordance with 24 CFR 85.20 and facilitate an effective audit to determine compliance with program requirements.
18. The PHA will comply with the Lead-Based Paint Poisoning Prevention Act, the Residential Lead-Based Paint Hazard Reduction Act of 1992, and 24 CFR Part 35.

19. The PHA will comply with the policies, guidelines, and requirements of 2 CFR Part 200, Uniform Administrative Requirements, Cost Principles, and Audit Requirements for Federal Financial Assistance, including but not limited to submitting the assurances required under 24 CFR §§ 1.5, 3.115, 8.50, and 107.25 by submitting an SF-424, including the required assurances in SF-424B or D, as applicable.
20. The PHA will undertake only activities and programs covered by the Plan in a manner consistent with its Plan and will utilize covered grant funds only for activities that are approvable under the regulations and included in its Plan.
21. All attachments to the Plan have been and will continue to be available at all times and all locations that the PHA Plan is available for public inspection. All required supporting documents have been made available for public inspection along with the Plan and additional requirements at the primary business office of the PHA and at all other times and locations identified by the PHA in its PHA Plan and will continue to be made available at least at the primary business office of the PHA.

Brattleboro Housing Authority (BHA) continues its mission to ensure the provision of quality affordable housing in viable communities for lower income households. In the winter of 2022 BHA in collaboration with local and statewide partners, the BHA Board of Commissioners, residents, participants and staff completed a 5 year strategic plan attached as an addendum to this plan.

BHA has aligned its's goals and objectives with the Vermont HUD Consolidated Plan by addressing four key areas:

1. Increase the supply and quality of affordable housing.
 - a. BHA Completed a 4.5-acre flood mitigation area at the former site of Melrose Terrace and received a Letter Of Map Revision from FEMA for the property. The remaining 1.5 acres of land is in the pre-development stage of housing redevelopment. BHA hopes to complete the redevelopment project and house 31 households in 2026.
 - b. BHA has requested a waiver in the 2024-2025 Moving To Work plan to expand its Project-Based Voucher (PBV) cap to be used for local housing development projects. BHA has guaranteed six PBVs to be used at the Windham and Windsor Housing Trust development project in Putney, VT, and is planning to apply to HUD to project base ten PBVs at a Windham and Windsor Housing Trust development project in Brattleboro. BHA intends to apply to HUD to project base thirty-one vouchers for a BHA redevelopment project in Brattleboro at the former Melrose Terrace site.
2. Decrease the number of people experiencing homelessness.
 - a. Between January and November of 2024, BHA housed forty-four new residents at BHA properties; of this group, 34% came from experiencing homelessness, and an additional 7% came from being either under-housed or at risk of being homeless.
 - b. BHA continues to implement the Shelter Plus Care Program, which serves people who are homeless, in partnership with local community service providers. BHA

housed four new households through the program.

- c. BHA will continue to house those most vulnerable to homelessness or who are homeless in 2025. BHA will continue to offer resident service programs to support housing retention.
3. Create and retain jobs.
 - a. BHA offered the HUD Family Self-Sufficiency Program, which focused on financial stability, education, and career advancement. BHA received a waiver from HUD to modify the program to meet our community's needs better. This included expanding the program to all those in the household over 18 years of age and allowing those on social security to participate if they would like to work in some capacity. The program now offers incentives to those furthering their education/ training or employment potential. The program coordinator works directly with the local community development organization to increase workforce training and options for residents. Participation increased in 2024 from 28 participants to 93 participants, a 232% increase in participation. This program will be expanded in 2025 to include the support of a new HUD-funded position, Resident Opportunity and Self Sufficiency Coordinator. BHA applied for an additional FSS Coordinator to support the increase in program participation.
 4. Strengthen communities and improve the quality of life of Vermonters
 - a. For the third year, BHA has been piloting a supportive services program called Support And Services at Home For All (SFA). SFA expands the traditional SASH model to support adults and families who are not Medicare recipients. SFA staff works with individuals and their families to assess their health and wellness needs, connect them with resources, and help them meet self-defined goals. Families struggling with financial security, well-being, and social connections receive particular focus. Initially funded through a Congressional Funding Request, the second year of the pilot is funded through the State of Vermont Department of Disabilities Aging and Independent Living. The BHA program now serves over 53 adults and 88 family members and has offered over 60 programs in 2024, including community building, food security, wellness, and educational events.
 - b. In 2023, the Public Safety Enhancement Team (PSET) supporting Governor Scott's 10-Point Safety Plan identified Brattleboro as a community with higher-than-average violent and drug-related crime rates. Since then, the town has organized a group of leaders named "One Brattleboro" to work together to address the problems. BHA Leadership has actively participated in the One Brattleboro group since its inception and will continue in 2025. Additionally, BHA will assign support staff to be part of the newly formed Situation Table group. The Situation Table group brings together multiple service providers to address the needs of individuals and families often facing the highest level of combined risks in the community.

BHA submitted its third Moving To Work (MTW) Supplemental Plan for year 2024-2025. The fourth MTW Supplemental Plan for fiscal year 2025-2026 is focused on improving administrative efficiencies and creating increased income deductions for certain populations.
